At all times, the County shall have the right to inspect the Contractor's work performed under this Contract. It is agreed that the services to be done under this Contract are to furnish all tools, labor, equipment and supervision necessary to provide Glock Firearm and Accessories when needed and requested by the County of Henrico in accordance with: (i) Invitation for Bid # 21-2157-4JEC dated May 19, 2021, including the general terms, conditions and requirements therein; (ii) Contractor's Bid dated May 29, 2021; and the Price Schedule included as Appendix A (collectively, the "Contract Documents"). The term of this Contract shall be from the date the last party signs through June 14, 2022 and may be renewed for up to four additional one-year periods. Pricing shall be in accordance with the Price Schedule included as Appendix A.

In consideration of the foregoing, which consideration is acknowledged by the parties to be sufficient and complete for all of the work within the scope of this Contract, the County agrees to pay the Contractor for all items of work performed and/or materials furnished at the unit prices or lump prices under the conditions set forth in the Contract Documents
