It is agreed that the services to be done under this contract are to furnish all tools, labor, equipment and supervision necessary to provide Ballistic Vests and Accessories to Henrico County in accordance with: (i) Invitation for Bid #20-1982-2YMD dated february12, 2020 including the general terms, conditions and requirements therein; (ii) and Bidder's Bid dated April 18, 2019; and the Price Schedule included as Appendix A (collectively, the "Contract Documents"). The term of this Contract shall be from April 1, 2020 through March 31, 2021 and may be renewed for up to four additional one-year periods in the County's sole discretion. Pricing shall be in accordance with the Price Schedule included as Appendix A.

In consideration of the foregoing services, which consideration is acknowledged by the parties to be sufficient and complete for all of the work within the scope of this Contract, the County agrees to pay the Contractor for all items of work performed and/or materials furnished at the unit prices or lump prices under the conditions set forth in the Contract documents.
