**Non-Professional Services Contract
Contract No. 2450B**

This Non-Professional Contract (this "Contract") entered into this 21st day of April 2023, by the County School Board of Henrico County, Virginia ("HCPS") and Playcore Wisconsin Inc. dba GameTime c/o Cunningham Recreation an Alabama corporation, and its successors it assigns (the "Contractor").

WHEREAS HCPS has awarded the Contractor this Contract pursuant to Request for Proposals No. 22-2450-11JEC, as modified by any addenda (the "Request for Proposals"), for Playground Equipment, Outdoor Fitness Equipment, Site Accessories and Related Products and Services to HCPS as set forth in the Contract Documents.

WITNESSETH that the Contractor and HCPS, in consideration of the mutual covenants, promises and agreements herein contained, agree as follows:

SCOPE OF CONTRACT: The Contractor shall provide the services to HCPS as set forth in the Contract Documents.

COMPENSATION: The compensation HCPS will pay to the Contractor under this Contract shall be in accordance with Exhibit A.

CONTRACT TERM: The Contract term shall be for a period of one year beginning April 21, 2023 and ending April 20, 2024. HCPS may renew the Contract for up to four one-year terms giving 30 days' written notice before the end of the term unless Contractor has given HCPS written notice that it does not wish to renew at least 90 days before the end of the term.

CONTRACT DOCUMENTS: This Contract hereby incorporates by reference the documents listed below (the "Contract Documents") which shall control in the following descending order:

1. This Non-Professional Services Contract between HCPS and Contractor.
2. The General Contract Terms and Conditions included in the Request for Proposals.
3. Contractor's Best and Final Offer dated March 16, 2023 (Exhibit B).
4. Contractor's Original Proposal dated January 4, 2023 (Exhibit C).
5. The Scope of Services included in the Request for Proposals.


